The Port is on pace to be the busiest Auto-port in the nation, and recent investments by the Georgia Ports Authority and Wallenius Wilhelmsen have positioned Colonel's Island to be the most advanced vehicle and large equipment processing port in the world

As we conclude these projects, we reflect on this community's commitment to economic development, and the foresight that our predecessors had to make critical investment in this organization and infrastructure. This year we celebrated the 100-year anniversary of the F.J. Torras Causeway, it was a day of celebration, but also, a reminder of the importance of having a vision for the future and the impact of investments that support that vision.

The GIDA is committed to investing in the future and thinks long-term. We invite everyone to join us to envision the community we want in 100 years and make investments in infrastructure and people that make our grandchildren proud.

Nurturing Growth









Our organization creates long-term and sustainable growth by investing in the attraction of new industries, industrial parks, and the expansion of entrepreneurship in the Golden Isles.


Since 2019, GIDA has participated in 7 announcements of \$178M in direct capital investment. The announcements include Hillpointe, Jered, Buc-ee's, Live Oak Fiber, Symrise, Second Harvest, and Weyerhaeuser Company.

\$300,000 in Share the Future Funds have been awarded in that time to Glynn County-based companies. These funds were in support of local expansions in the community.


GIDA also reviews and provides recommendations on Glynn County's Revolving Loan Fund. In the past 5 years, GIDA has recommended \$297,000 in loans to the Board of Commissioners.

Total Wages & Household Income

The attraction and expansion of businesses have a ripple effect on the overall economic well-being of a community. GIDA pays close attention to how Glynn County is trending in wages, employment, Gross Domestic Product, number of private establishments (establishments that produce a good or service), and our industrial sector's overall value. The charts below illustrate the growth for the most current years available.




Average annual wages per worker increased 2.7% in the region over the preceding four quarters.




Private Establishments for All Industries

In the past four years, the number of private establishments (establishments that produce a good or service) in Glynn County has grown significantly from 2,677 in 2020 to 3,320 in 2023. This is a 24% increase in private establishments operating in the Golden Isles over the past four years.



Median Household Income

The wage increase has had a positive impact on the median household income, which has increased by 20% between 2019 and 2022.



Gross Domestic Product Growth

Gross Domestic Product (GDP) is the total value of goods and services produced by a region. In 2022, nominal GDP in Glynn County, Georgia, expanded by 9.4%. As of 2022, the total GDP in Glynn County, Georgia, was \$5.28 billion.



PLACEMAKING

Golden Isles Mattress

Golden Isles Mattress, female-owned and operated by Lauren Sobala, has been a local business operating for approximately 7 years in Glynn County.

Problem: Business at Golden Isles Mattress is booming, leading to expansion to a new location. To ensure safety and appeal, the new site needed proper lighting, clear signage, and exterior enhancements. These improvements enhanced customer visibility, create a welcoming atmosphere, and support the store's continued growth and success.

Solution: Enhance safety and visibility at our new location by installing adequate lighting, clear signage, and improving the façade.

Results: The exterior of the new facility's aesthetics increases safety and the business's attractiveness and/or competitiveness. Golden Isles Mattress was approved to receive \$10,000 through our Share the Future grant and allocated to a new exterior sign.

We Make, We Thrive

The industrial sector is a vital component of the local economy and the focus of the GIDA's attraction and expansion efforts. Some of the greatest ad valorem tax-paying entities in Glynn County are industrial facilities.

Furthermore, because manufacturing is a capital-intensive activity, industrial property generally represents more value to the tax digest than other uses. Industrial acreage accounted for only .62% of the total acreage in Glynn County but accounted for 10.0% of the total digest value (2023).

As of the first quarter of 2023, there were 1,954 people employed in manufacturing in Glynn County, and manufacturing paid an average annual wage of \$72,792, a wage that is 42.1% higher than the average of all industries in Glynn County (\$51,228).

Golden Isles Gourmet Popcorn

Golden Isles Gourmet Popcorn (GIGP) is a newly created, woman-owned local manufacturing company located in Brunswick, Georgia. GIGP is designed as a premium gourmet popcorn and specialty snacking experience GIGP will be sold at local events and celebrations, local businesses in Brunswick and SSI, and eventually expanding to an online store.

Problem:

GIGP required funding to acquire two out of the four essential pieces of equipment necessary to launch a high-volume popcorn company. This investment enabled GIGP to efficiently produce large quantities of popcorn, meet market demand, and ensure the highest quality standards.

Solution:

Equipment to increase the production capacity, enhance the supply chain efficiency, and meet the growing demand of the facility.

Results:

GIGP received a grant of \$5,000 from GIDA to support the purchase of this crucial equipment. The equipment will facilitate the growth of the facility, enabling it to expand its operations and explore new business avenues.


Keeping it Local

Not only do we want our entrepreneurs and main street businesses to succeed, but we recognize the benefits shopping local has for our community. For every dollar spent at a small business in the U.S., approximately 67 cents stay in the local community. We strive to purchase local as much as possible to support our business community.

\$60,000 of our budget expenditures went to local businesses through our Share the Future Initiative. At least 65% of our controllable spending was with local businesses. Everything from engineering work for clients, print material, or office supplies - GIDA thinks, and spends, local first.

Your Progress explained...

Jered Expansion Groundbreaking: Jered, a PAR Systems company, proudly announced the groundbreaking ceremony for its highly anticipated 100,000 square foot expansion in GIDA's McBride Industrial Park on March 26, 2024. The partnership between GIDA and Jered, Inc., has been a cornerstone in their expansion. GIDA agreed to issue taxable revenue bonds to finance the \$45,000,000 investment. This monumental addition marks a significant milestone for Jered, solidifying its commitment to enhancing manufacturing capacity for military-grade marine systems utilized by the U.S. Navy, while fostering substantial growth for both the business and the Golden Isles community.

Hillpointe Announces Development Plans: The GIDA Board of Governors approved a sale and lease agreement with Hillpointe, LLC in January of 2024. This agreement, finalized during GIDA's monthly board meeting, marks a pivotal step for the Tradewinds Technology Park, with Hillpointe, LLC planning to develop a 55-acre site into a state-of-the-art warehouse and office facility, totaling approximately 502,500 square feet. This will be the first building to rise in the park, located off Exit 42 near Interstate 95. The project is expected to be a catalyst for growth, bringing new jobs and businesses to the area, and is seen as a strategic investment in the future prosperity of the Golden Isles region.

Buc-ee's Celebrates Groundbreaking: In February 2024, Buc-ee's broke ground on a new 74,000 sq/ft facility at Exit 42 in Glynn County, creating over 200 full-time jobs with competitive benefits, including above-minimum-wage pay, a 401K, and three weeks of paid vacation. In partnership with the Golden Isles Development Authority (GIDA), Glynn County committed \$3 million for Exit 42 improvements, including upgrades to Highway 99, traffic signalization at ramps, and new intersections. These enhancements will benefit the entire Exit 42 interchange and support Buc-ee's and future businesses in the area.

Innovation Isles Aerospace Park GRAD Certified: The Georgia Department of Economic Development (GDEcD) and GIDA announced in May of 2024 that the Innovation Isles Aerospace Park has earned a "GRAD Select" certification, marking it as highly attractive for industrial development. This 650-acre site, located in Brunswick near the Brunswick Golden Isles Airport and the Port of Brunswick, is ideal for aerospace manufacturers and service companies due to its strategic location and rapid market access. The GRAD Select status indicates that the site has met rigorous certification standards, enhancing its appeal to potential investors.

America's Second Harvest Ribbon Cutting: Second Harvest of Coastal Georgia, a volunteer-run organization dedicated to ending hunger and improving lives in the region, celebrated the opening of its new \$6 million facility on February 12, 2024. Located at 2591 Sidney Lanier Drive, the 55,000-square-foot building is significantly larger than the previous Brunswick warehouse. The grand opening event was attended by food bank staff, community members, and state leaders. Second Harvest operates a main branch in Savannah and encourages the community to support its mission through food drives, donations, and spreading awareness.

New Collaborative Space for GIDA and the Lucas Center for Entrepreneurship: The Golden Isles Development Authority (GIDA) and the College of Coastal Georgia (CCGA) announced in January of 2024 GIDA's move to a new space with CCGA's Lucas Center for Entrepreneurship in Downtown Brunswick. The move reflected GIDA's commitment to fostering entrepreneurship and economic growth in Glynn County. The new space offers resources such as mentorship, workshops, and funding opportunities, all aimed at supporting local businesses. This partnership was seen as a key step in building a thriving community.

Your Progress explained...

Brunswick Cellulose is named Intl Business of the Year: World Trade Center Savannah (WTCSav) held its fifth annual Prosperity Through Trade Luncheon on May 2, during World Trade Month. At the event, WTCSav awarded the World Trade Center Savannah International Business of the Year Award to Georgia-Pacific's Brunswick Cellulose pulp and paper mill. The mill, a major employer in Glynn County since 1937, employs 650 people and is the county's largest taxpayer, paying over \$3.7 million in the current tax year. Georgia-Pacific, headquartered in Atlanta, is one of the world's largest recyclers and operates more than 150 facilities, employing approximately 30,000 people and creating over 80,000 indirect jobs.

Talent Development Strategy: The Golden Isles Talent Development Strategy annual action items are executed by GIDA and the Brunswick-Golden Isles Chamber of Commerce (BGICOC). This year the Strategy delivered on two major initiatives: the Connect Glynn Educator Externship Academy and The Book Space. The Externship Academy offered Glynn County educators a four-day program to engage with local employers, providing real-world industry experience to enrich classroom learning. The Book Space, a repurposed school bus turned bookmobile, was launched to promote literacy and provide accessible books to the community. Both initiatives aimed to enhance education and community engagement in Glynn County.

Pinova Employees Secure Careers: In response to the closure of Pinova, GIDA and BGICOC partnered with Pinova to launch a support initiative for affected employees. This included creating a local job portal on GIDA's KeepGlynnRunning.com and hosting a job fair with 40 local businesses. The event facilitated immediate interviews, resulting in 25 former Pinova employees securing new positions during the event. Overall, all 200 employees have been placed in careers throughout the county and region, with significant assistance from GIDA.

Keep Glynn Running: GIDA has always emphasized the importance of Glynn County's manufacturing industry for economic resilience, job creation, and innovation. To support this sector, in 2020 GIDA launched the "Keep Glynn Running" (KGR) campaign, reaching 10,000 residents with its message just this past year. The KGR website provides resources on the benefits of working in the local manufacturing and engineering sectors, including on-the-job training, higher wages, and career advancement. It also features a job portal pulling from nearly 30,000 job boards, helping local residents explore career opportunities in Glynn County.

2nd Annual Manufacturing Appreciation Dinner: GIDA is proud to host this annual Appreciation Dinner to recognize the significant impact of the local manufacturing industry. The local industry employs 2,776 individuals with an average wage of \$75,019, contributing \$400 million to the county's GDP in 2022. Despite industrial acreage making up only 2.4% of the county, it accounts for 11.7% of the tax digest value. Awards were presented, including the Innovation Excellence Award to Recovery Solutions Worldwide and Manufacturer of the Year to Jered LLC, and the Dave Smith Award for outstanding service went to Woody Woodside for outstanding service acknowledging Dave Smith's lasting influence on the community.

Small Business Rockstar: Each year, GDEcD and the Georgia Economic Developers Association recognize exceptional small businesses as "Small Business ROCK STARS" for their innovation, outreach, and impact on the state. In May of 2024, Downtown Brunswick's Grace Graffiti won this years prestigious award. "We're honored to receive the Small Business Rock Star award and consider it not just ours, but a testament to the Brunswick community that has supported us so strongly." Looking AheadStrategic Vision 2024-2026

The GIDA team uses OKRs (Objectives and Key Results) as a goal-setting framework that helps our organization define measurable goals and track outcomes. In August of 2023, the GIDA Board of Governors and staff met to review the strategic vision for fiscal years 2021-2023 and determine priorities for fiscal years 2024-2026. Here are some highlights of what will be included in our Strategic Vision for fiscal years 2024-2026.

Talent Attraction

Talent attraction is vital for economic development because it forms the foundation for business attraction and growth, innovation, and economic prosperity. The 2021 American Community Survey states that Glynn County has a prime-age labor force (ages 25-52) of 24,652. It is one of our top initiatives to increase this number by 2% each year through the development of a Talent Attraction Strategy in partnership with our educational and community partners. This priority will be executed in conjunction with our annual goal to reach 10,000 Glynn County residents through our Keep Glynn Running (KeepGlynnRunning.com) message to spread awareness of the abundant career opportunities within the Golden Isles.

Site Development

GIDA must have sites to offer industries looking to expand and locate their respective facilities. The GIDA is currently undergoing the GRAD Certification (Georgia Ready for Accelerated Development) process for over 1,400 acres at Georgia Breakbulk Logistics Park located adjacent to US Highway 82 off of Exit 29 to stay competitive in attracting businesses.

Industry and Leadership Roundtables

Industry roundtables are important for fostering collaboration, problem-solving, and growth within a specific industry. GIDA will hold quarterly industry roundtables for existing industries in the Golden Isles to bring together key stakeholders to help create an environment conducive to innovation, economic development, and long-term prosperity.



WE INVEST in our community

It has been a tremendous professional privilege to serve as the Chair of the Board of Governors for GIDA over the past year. I extend my heartfelt thanks to the Board and GIDA staff for their vision and leadership, which have been instrumental in laying the groundwork for our region's economic growth, stability, and prosperity.

It has become increasingly evident that our success hinges on collaboration. This year, we partnered closely with local elected officials and industry on several key projects, partners alongside working the State Department of Economic Development and national Site Consultants. Our efforts resulted in two ribbon-cutting ceremonies with \$15 million investment and 20 new jobs, two groundbreaking events with \$90 million in investment and 250 jobs, and contracts for two projects expected to bring \$75 million in investment and 100 new jobs.

Their leadership has equipped the GIDA staff with the resources necessary to implement our vision and the insight to continue these efforts.

As we look forward into our next fiscal year, I am confident that the GIDA Board and staff will continue to deliver sustainable results that positively community. Their impact our dedication to expanding and attracting existing industries and has demonstrated that GIDA is wellequipped to secure significant new projects, further bolstering the vibrant economy of the Golden Isles.
