#### **CHAIRMAN'S ITEMS**

#### **Grant Award Announcement**

Ryan Moore and Chairman Christy Jordan gave an update on the grant award for two million dollars for the breakbulk site off Hwy 82 for the new concept approved by Department of transportation with two access point at a total cost of 3 million dollars. The timeline for completion is the end of the year 2025.

#### **Approve 2025 Meeting Schedule**

**A MOTION** was made by Bill Dawson, seconded by Darren Pietsch, and passed unanimously to approve the 2025 meeting schedule as presented. The **MOTION** carried unanimously: 5-0.

#### **NEW BUSINESS**

#### Share the Future (STF) Grant Consideration for Genesis Greens LLC Innovating

Macs and Barnabas Szekely presented the Genesis Greens LLC project, while Ryan Moore provided an update on the Share the Future funds. Ryan Moore requested an extension of the grant amount to approve a \$6,500 grant with GIDA contributing up to \$3,250 of the dollar-for-dollar grant.

**A MOTION** was made by Richard Nixon, seconded by Bill Dawson, and passed unanimously to approve the Share the Future for Gebesus Greens LLC as presented. The **MOTION** carried unanimously: 5-0.

#### Consideration of Engineering Services Proposal for Breakbulk Entry Design

Ryan Moore provided an update on the proposal for the breakbulk entry design by Thomas and Hutton and recommended its approval.

**A MOTION** was made by Daren Peitsch, seconded by Richard Nixon, and passed unanimously for engineering services design with Thomas and Hutton as presented. The **MOTION** carried unanimously: 5-0.

# **Consideration of Proposal of Grant Management Services**

Ryan Moore reported that the Coastal Regional Commission has assisted with managing grants in the past and is requesting they manage the current grant. Although there is no proposal or agreement in place yet, their services have come at no cost in the past.

# Consideration of Commercial Investment Incentive Policy

Ryan Moore presented a commercial investment incentive policy for the board to review and adopt. The policy would serve as a guideline for the staff and would establish a threshold framework with flexibility for future use.

# PRESIDENT'S INFORMATIONAL ITEMS:

# SEGA JDA Strategic Planning

Ryan Moore provided an update on the SEGA JDA strategic planning, explaining that the authority is a state-approved entity for establishing a regional authority. SEGA meets monthly

and consists of six coastal communities: Camden, Brantley, Glynn, McIntosh, Charlton, and Wayne. SEGA concentrates on the southeastern region, organizing events at the capital, the Southeast Georgia Conference, Site Selection Guild, and various outreach activities to enhance its presence and benefit all six county authorities.

## **NEW BUSINESS ATTRACTION**

#### Project Update

McKenzie Padgett reported that there are 21 active projects, with advanced manufacturing consistently generating the highest number of inquiries.

#### RSM

McKenzie Padgett reported that this year's RSM event had excellent attendance, with new project managers taking part. Guests were given the chance to take a plane tour to explore available sites in the community. In addition, a day was set aside for the manufacturing community to attend the event.

Matt Henderson and Tommy Sydner of WWL led the tour at the port. After the port the group visited MAP International and had the opportunity to meet their new President and CEO, Chris Palombo.

# Chick-fil-a lunch for Manufacturer of the Year Recipient: King and Prince Seafood

Sherri Pruitt reported that the Manufacturer of the Year, King and Prince Seafood, celebrated with their entire team treated to lunch from Chick-fil-a. King and Prince was recognized for their impact and commitment to the community and their employees.

Sherri Pruitt reported on the GAMA event, noting that the U.S. is becoming more receptive to hybrid and hydrogen vehicles, while electric vehicles (EV) are experiencing slower growth, with a projected 10-year progression. She emphasized that AI is here to stay and should be embraced, but from an HR perspective, human connection remains crucial, as 70% of employees leave due to management issues. Therefore, AI should be used, but not as a standalone solution.
