NEW BUSINESS

Consideration of Amended FY24 Budget

Ryan Moore request item differed to next meeting.

Consideration of Investment Policy Statement (IPS)

Ryan Moore reported that Daren Pietsch and Greer Anderson served on the Investment Policy Committee (IPC) to develop an IPS for the authority. Synovus Bank has been hired to manage the funds. The IPC and legal have both reviewed the IPS. Daren Pietsch says it's flexible for and allows for amendment as needed and recommends approval.

A MOTION was made by Daren Pietsch, seconded by Bill Dawson, and passed unanimously to adopt the Investment Policy Statement as presented. The **MOTION** carried unanimously: 4-0.

Authorize New Signers for First Chatham Account

Ryan Moore reported that it has been the policy of the Authority to reinvest in CD's and all five of the board members need to be added as signers to the First Chathem Accountand allow Joan Hearn, financial consultant staff, to have access to the account.

A MOTION was made by Greer Anderson, seconded by Daren Pietsch, and passed unanimously to approve the board members for signers for First Chatham accounts and Joan Hearn for access to the account as presented. The MOTION carried unanimously: 4-0.

UPDATES

PRESIDENT'S INFORMATIONAL ITEMS:

Southeast Georgia Alliance (SEGA) Mixer Update

Ryan Moore reported that the Southeast Georgia Alliance is comprised of a six-county regional alliance with real estate that includes rail service from both CSX and Norfolk Southern. Jan Melcher is the Executive Director for SEGA. SEGA has a new brand image along with a stronger social media presence. SEGA had a mixer in the GIDA large board room with board members invited from each county to help each community recognize the benefit of the regional partnership. Good reception with opportunity to share the benefits and vision of SEGA.

NEW BUSINESS ATTRACTION

Project Update

McKenzie Padgett reported that the Authority has lost three projects from the list to other states. However, the Authority has had three site visits this month with one in Atlanta that several Authority's applied for but only a handful of Authority's were invited to present, our Authority being one of them. The Golden Isles Development Authority was one of six authorities given a 15-minute slot to present. Ryan Moore noted this was due to McKenzie Padgett's hard work.

GEDA Spring Workshop

McKenzie Padgett reported on the GEDA Spring Workshop coming up May 22, 2024, and this year it is being held at Sea Palms on Saint Simons Island. A **MOTION** was made by Daren Pietsch and seconded by Bill Dawson to return to Open Session. The **MOTION** carried unanimously: 4-0.

Returned to Open Session

A MOTION was made by Bill Dawson and seconded by Greer Anderson to give Ryan Moore the authority to direct Gilbert Harrell Sumerford and Martin to seek a "Bona Fide Purchaser" status letter from the Environmental Protection Agency. The letter would provide protection against past environmental contamination should the authority choose to take possession of the former Brunswick Wood Treating facility, located on Perry Street in Brunswick, Georgia. The MOTION carried unanimously: 4:0.

A MOTION was made by Bill Dawson and seconded by Greer Anderson to give Ryan Moore the authority to negotiate with the Georgia Environmental Protection Division ("EPD") to assign a lien currently held by EPD on the Brunswick Wood Treating facility to the authority. The lien assignment, in the form of a consent order with EPD, would allow the authority to satisfy the lien by foreclosing on the Brunswick Wood Treating facility. The MOTION carried unanimously: 4:0.
