NEW BUSINESS

Glynn County Funding

Ryan Moore reported that the Glynn County Board of Commissioners recommends a contract for one year with Golden Isles Development Authority while discussions continue regarding future funding, subject to legal review.

A MOTION was made by Daren Pietsch seconded by Bill Dawson and passed unanimously to approve extensions of the Glynn County contract for one year as presented, subject to legal review. The **MOTION** carried unanimously: 4-0.

Share the Future (STF) Expansion Consideration

Ryan Moore gave a review on the Share the Future funding and recommends expanding the funding to include Aviation and increasing the budget to accommodate the additional funding. **A MOTION** was made by Daren Pietsch seconded by Bill Dawson and passed unanimously to increase the Share the Future budget from \$80,000 to \$120,000 and adding Aviation to the Share the Future funding projects as presented. The **MOTION** carried unanimously: 4-0.

Consider Share the Future (STF) Grant Requests

Sherri Pruitt gave an update of the Share the Future projects and the Authority recommends the awarding the following applications:

A MOTION was made by Bill Dawson, seconded by Greer Anderson, and passed unanimously to approve the Share the Future recipients as presented. The **MOTION** carried unanimously: 4-0.

Revolving Loan Fund (RLF) Recommendation

Sherri Pruitt gave an update to the board on the RLF applicants. Three excellent investments opportunities applied, and the Authority is recommending Eckerd Seafood Industry for the remaining funding. Eckerd Seafood is a seafood market industry that has been in business located at Bay Street for almost 30 years. They are looking to purchase a freezer in the amount of \$300,000 for expansion.

A MOTION was made by Daren Pietsch, seconded by Bill Dawson, and passed unanimously to approve the RLF for the remaining amount of \$97,000 as presented, subject to legal review. The **MOTION** carried unanimously: 5-0.

FINANCIALS

Approve June Financials

Joan Hearn reviewed the financials with the board noting that the Authority is slightly over budget due to groundbreakings and additional marketing events.

A **MOTION** was made by Daren Pietsch and seconded by Greer Anderson and to approve the June financials as presented. The **MOTION** carried unanimously: 4-0.

Investment Updates

Freddie Zeh and Erika Chambliss with Synovus Bank presented funds options from the FLETC dorm sell and will act to manage assets and investment. Synovus Bank will present monthly results to Ryan Moore and Joan Hearn, quarterly reports to the finance committee, and yearly reports to the Board.

Presentation of Annual Report

Ryan Moore presented the annual report to the board and distributed the brochure to the booklet to everyone in attendance.

Project Update

McKenzie Padgett reported that projects continue to come in with advance manufacturing remaining the largest inquiries.

Southern Economic Development Council (SEDC) Conference

Ryan Moore attended the SEDC conference with allies from seven states attending. One topic of particular interest was a presentation on the "Impact of Youth Sports Facilities" was presented noting a big trend now in sports facilities with flexibility for commercial and retail opportunity and a good opportunity for the Authority to explore. Tradewinds Technology Park Groundbreaking

Ryan Moore reported on the HillPointe property groundbreaking. The groundbreaking had a great attendance and will house a distribution company along with 250,000sf of speculative space available in less than a year. This is the largest industrial building in the County.

RSM Experience

Ryan Moore reported on the RSM showcase event coming up in October with more to come.

EXISTING INDUSTRIES

Port Tours

Sherri Pruitt reported on two tours the Authority facilitated at the Brunswick port to showcase the growth at the port. One tour included the County Manager, County Commissioners, and Authority Board members. The second included the City Manager, City Commissioners, Downtown Development Authority, GCAC staff, etc. Wallenius Wilhelmsen and the Georgia Port gave a very informative tour of all the progress at the Brunswick port.

WORKFORCE

Tour of Brunswick Job Corps Campus

Ryan Moore reported that the Authority was able to do a tour of the Job Corps campus equipped with home builders institute labs for electrical, HVAC, plumbing, etc. The current administration is very intent on making this community-driven with students coming from within 50 miles of the campus and approximately 200 students in a 6 month to 1 year program. The biggest limiting factor is dorm space. More to come.

KGR First Friday Workforce Showcase

McKenzie Padgett reported the Authority, Costal Pines Technical College, and Golden Isles College and Career Academy will be launching the quarterly Keep Glynn Running Workforce Showcase at the First Friday event. This will include the welding lab, heavy machinery simulator, etc. More to come.

Ryan Moore was on the panel of five for the 2024 Chamber State of the Workforce hosted by the Chamber. Chairman Christy Jordan reported that it was a very informative of all the great work going on in the community and the long-term investments being made in the community.

Ryan Moore reported that he presented the FY 2024 Year in Review to the City Commission meeting. The Authority updates the City twice a year and it's always well-received with good conversation.

FJ Torras Causeway Centennial Celebration Update

Ryan Moore reported on the seamless and well-done event honoring the FJ Torras Causeway Centennial event. There were over 2,000 guests along with 80 sponsors, including Governor Brian Kemp and Congressman Buddy Carter. The Torras Foundation contributed \$5,000 to the KGR organization after the event was completed. All and all a exceptional event.
