Consideration of Inducement Resolution

Ryan Moore presented the Inducement and intergovernmental agreement with Buc-ees that would allow development in Glynn County. The agreement would be that the County would fund a \$3 million investment for road work at the interchange, including traffic signals and improvements to the right of way along Ga. 99 to support Buc-ees and future businesses along the corridor. Most of the traffic generated (approximately 70%) will be coming from out of the county that would not otherwise stop here. Buc-ees will be investing more than 30 million in the site and creating 175 jobs.
